 Complete the MDCC Health Science application
 Register for and successfully complete Anatomy & Physiology I (BIO 2513/2511) and Anatomy & Physiology II (BIO 2523/2521) with a 'C' average or higher <b>before program start date</b> . <i>NOTE: A&amp;P I and II must be completed within the last 5 years</i>
 Completion of Fundamentals of Radiology (RGT 1213) with a grade of "C" or better during the regular or summer session <b>prior to the start date of the RT program</b> .
 E-Script or mail all official transcripts (including High School) to the MDCC Office of Admissions. All transcripts must be <b>on file by April 1</b> <sup>st</sup>
 Submit ACT scores to the MDCC Ofice of Admissions. Must be on file by April 1 <sup>st</sup>
 Register to take the TEAS entrance test. You must register for this test online at www.atitesting.com (instructions are found on the last page of this application). The TEAS test will be offered in person on the MDCC campus at Moorhead on February 7&8, 2025. During the registration process, you will be given the option to select your testing site <b>OR</b> the TEAS test is taken VIRTUALLY. The TEAS must be taken within 18 months of application deadline. It can only be taken 2 times 45 days apart during the application year. If you submit test scores taken at any other time, the score will not be accepted. The TEAS must be taken <b>prior to April 1st</b> AND must be sent to us directly from ATI, not the student.
